## Full-featured Reliable Phone System



Talking directly to clients over the phone is imperative because the SEC doesn't allow taking buy or sell orders via email. For that reason, keeping phone lines working properly is also crucial.

*"Ten years ago, we didn't have a rollover to cell phones. Since working with ITS, if our phone lines are down when people call our main number, it rings my cell phone or one of our other employee's cell phones," LeMond said. "ITS keeps us up and running."*

ITS also converted The Investment Counsel Company from on-site servers to the cloud. "That actually worked very well. Everything is stored in the cloud. Not only does it safeguard the information from someone breaking into the office, but it also safeguards the information if there should be some kind of catastrophe, such as the building burning down or some other disruption in business," LeMond said. Plus, ITS backs up our server several times a day to three different geographical sites.

The ability to securely access information and software from any desktop, laptop, or mobile device gives them the added flexibility they need to stay operational under any circumstances.
